A motion (Kern/Terrill) to approve the minutes of the December 2021 meeting as published passed 11-0-0.

A motion (Connolly/Hawthorne) to approve the minutes of the January 2022 meeting as published passed 11-0-0.

TREASURER: Gene Kern

Gene delivered the current report.

There was a large drop in the balance this month because we made the deposits for all our race events scheduled for this year.

MEMBERSHIP: No one here to give a report.

SOLO: Joe Montuoro

Dates for our Solo events at PittRace are set. 5/14 is a Starting Line school for novices. An EVO school for experienced drivers is scheduled for the second weekend in July (7/9-10). April 3rd there is a Test & Tune, limited to 50 entries. Each entrant should get 12 to 16 runs.

There will be an autocross meeting Monday 2/21 at 7:30PM. We will discuss whether we need a new public address system or not.

John, our Chief of Timing, is working with Darrin from Pronto to produce a custom system for us.

RALLY : Chuck Larouere

Our 2022 National Tour rally will held April 30, and the Divisional Rally will follow on May 1st. We will also do the Pittsburgh Vintage Grand Prix rally.

We are planning a rally for the Supertour and for the driver's school.

We have made the deposit for the trial at Summit point, and we are working on the schedule.
